The company conducting the orientation (Praesidium) is a well respected provider of protection programs and may already be familiar to you. We would encourage you to participate in the webinars they are offering; they may be helpful to you in establishing a policy/program if you don't already have one, or they may give you additional helpful insights.

Dear partners,

We are grateful for your continued partnership and hope that you, your colleagues, and those you serve are remaining healthy as the world progresses together through the COVID-19 pandemic. We continue to stand with you in solidarity during these challenging and unprecedented times.

Over the past ten months, the Catholic Sisters Initiative has been preparing to roll out a new safeguarding policy for our grantees and partners that will build our collective capacities to put in place systems that protect the rights and well-being of children and vulnerable adults who are served by our programs.

I am pleased to share that the Conrad N. Hilton Foundation Catholic Sisters Initiative, in partnership with the Foundations and Donors Interested in Catholic Activities (FADICA), will begin the rollout of our new safeguarding program this month.

The first activity will be a series of webinars for grantees. This capacity-building effort will include expert training and sample policies that are being offered by our partner, <u>Praesidium</u>, at no cost to you. The first webinar will be on April 23 at 12:00 p.m. PST / 3:00 p.m. EST. This one-hour webinar will provide:

- A high-level overview of best safeguarding practices
- Introductory but practical steps for developing safeguarding policy in directservice organizations. What are the bite-size, manageable pieces that are most important and universal for all sectors?
- An acknowledgment of the unique safeguarding challenges posed by COVID-19, specific to the sectors in which grantee partners are working

In addition, we will begin implementing changes to our grantee agreement letters. Existing grantee agreements are not being modified; however, moving forward, we will require our partners to confirm the existence of, or intention to create and implement, safeguarding policies and protocols that protect the safety of children and vulnerable adults who may interact with the organization's employees, volunteers and programs.

I hope that you are able to take advantage of this webinar and of any additional sessions to follow. We will keep you informed as these and other resources become available.
